The Hemphill County Commissioners offer no objection to the location on the right-of-way of your proposed \_\_\_\_\_ line as shown by accompanying drawings and notice dated \_\_\_\_\_ except as noted below.

It is expressly understood that Hemphill County does not purport, hereby to grant any right, claim, title or easement in or upon this highway, and it is further understood that Hemphill County may require the owner to relocate this line, subject to provisions of governing laws, by giving thirty (30) days written notice.

\_\_\_\_\_ shall hold harmless and indemnify the Commissioners' Court of Hemphill County, Texas, against any and all damages to property or injuries to persons caused by the proposed construction, and by acceptance of this approval agrees to make all changes and alterations to said utility lines as may be required in connection with alteration, paving or relocation of any public road, without cost to Hemphill County.

All work on the highway right-of-way shall be performed in accordance with Precinct Commissioner's instructions. The installation shall cause minimum inconvenience to traffic and adjacent property owners. Special specifications for placing this utility line are as follows:

1. The line shall be placed through hole bored beneath road.
2. The line must be cased, or heavy wall pipe must be used, to extend from right-of-way line.
3. All borings on paved highways shall extend for the full width of the paving and ten (10) feet on each side thereof, or for the full width of the road bed in all cases.
4. The casing shall be of approximately the same diameter as the hole bored, or cut as the case may be.
5. All pipe or lines shall be well covered beneath grade line in ditches in order not to interfere with the blading of ditches. 60" cover at lowest point. Electric lines must be 60" at lowest point. Telephone lines must be 48" at lowest point.
6. All lines shall be permanently marked with industry standard markers depicting location on each side of road and located on ROW line of county road.
7. Must comply with all State and Federal Laws.
8. **WILL INSURE THAT CONTRACTOR OR SUB-CONTRACTOR WILL NOT OPERATE TRACK TYPE VEHICLES ON OR ACROSS COUNTY ROADS.**
9. **CONTRACTOR IS LIABLE FOR ALL DAMAGES TO COUNTY ROADS AND IF REPAIRS ARE NECESSARY, FOR THE COST OF THOSE REPAIRS.**
10. **YOU MUST ATTACH A COPY OF THE HEMPHILL COUNTY ROAD MAP WITH THE LOCATION NOTED AS TO WHERE YOU PLAN TO BORE AND SITE LOCATION SHALL BE VISIBLY MARKED ON GROUND FOR INSPECTION PRIOR TO SUBMITTING PERMIT APPLICATION.**
