# NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$ 0.035000 per \$100 valuation has been proposed by the governing body of Hemphill County Underground Water Conservation District.

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for Hemphill County UWCD from the same properties in both the 2019 tax year and the 2020 tax year.
