

Ranch 10, 10.01 ACRES

A tract of land in Hill County, Texas, containing 10.01 acres within the S. S. Pool Survey, Abstract No. 715, being a portion of the called 1068.43 acre tract described in the deed to The Ranches at Rock Creek, LLC, recorded in Volume 2107, Page 164, Official Public Records of Hill County, Texas and being more particularly described as follows:

Beginning at a 5/8 inch iron rod set for a corner, bearing North 30 degrees 52 minutes 24 seconds West a distance of 915.07 feet and North 59 degrees 11 minutes 46 seconds East for a distance of 477.06 feet from a 5/8 inch iron rod found in the east right-of-way line of F.M.
