He said he bought two new vehicles with all the equipment required, Daniel Defense Riffles for each deputy, Life Vac for each deputy's vehicle, one Life Vac for sheriff's office and two Life Vac for the jail and Staccato Pistols for each deputy which leave \$.13 cents to send back to the State. He said with next year's grant he will continue the stipend for each deputy and Jailer and purchase 3 vehicles depending on the price.
