## Budget Workshop

Judge Johnson and Treasurer Kay Smallwood explained to the court that there will be a raise in cost to County Employees health insurance of up to 8 percent.

Judge Johnson stated that the Clerk's Election Stipend of \$1,200.00 per election is going to be covered in the existing election judge's line item budget without increasing it.

Judge Johnson said that they added the line item for Locust Grove Volunteer Fire Department at a cost of \$3,000.00 annually.

Judge Johnson explained the spreadsheet that she gave to the court regarding decreases and increases in the 2024-2025 Proposed Budget.

There is a possibility for a tax raise of \$.05-\$.06 due to the decrease in tax valuation.

#### **Announcements**

Judge Johnson explained things that have been purchased for the Emergency Operation Center which includes, two television screens, a new camera, two way radio, printer and phone line. It has not been completed yet but it's estimated to cost about \$10,000.00 with Michael Kerrigan's time included.

Judge Johnson is still waiting on a second quote for the arena lights from B&G Electric.

Texas Forest Service Director, Al Davis, is taking steps to improve their wildfire response. Judge Johnson stated that they are taking great steps in improving the way they fight fires.

A fire mitigation meeting was held on July 2<sup>nd</sup> with Forest Service Team, City of Canadian, Fire Department and TDEM. Mitigation Project objects were discussed including clearing some dead trees down by the river, take out mesquite trees behind the Wilhelm's by Hackberry. There is a non-profit company that will help at no cost.

There was electrical damage to the walking bridge from the fire. Some repairs were made, but there is still more work that needs to be done.

Rodeo arena stalls have been ordered but still waiting for them to arrive to be installed.

#### **Future Agenda Items**

Judge Johnson stated that there will be a couple of road closures probably by the July 29<sup>th</sup> meeting, if not by August.

Judge Johnson said that they will be looking at proposed tax rates and the adoption of budget and tax rate in August.

#### Approve Bills, Budget Amendments, Treasurer's Report.

Tim moved to approve the Treasurer's Report. Dale seconded the motion which carried unopposed.

Dawn moved to approve the computer generated bills. Dale seconded the motion which carried unopposed.

Tim moved to approve the hand stamped bills. Dale seconded the motion which carried unopposed.

Dawn moved to approve seven invoices from Schafer Services for \$3,900.00, \$3,900.00, \$3,900.00, \$3,900.00, \$89.25, \$200.00, \$164.24 and \$190.58 for a total of \$12,344.07. Tim seconded the motion which carried with Dale abstaining.
