BEGINNING at a 5/8° iron rod found in the west line of State Wighway 32 for the southeast corner of said Lot 9 and for the

southeast corner of this:

THENCE with the south line of said Lot 9 and generally along a fence as extended, N69°35' 40"W 139.85 feet to an iron spike found at a metal fence portion for the southeast corner of that certain tract described in a deed to Nicky D.
