**TO: ALL OF THE UNKNOWN OWNERS OR CLAIMANTS OF ANY TITLE OR INTEREST OWNED BY CALVIN W. ISAACS, DECEASED AT THE TIME OF HIS DEATH ON FEBRUARY 21, 1955, IN THE LANDS OWNED BY CALVIN W. ISAACS AND HIS BROTHERS, JOHN C. ISAACS, II AND DAVID QUENTIN ISSACS, SR., INCLUDING BUT NOT LIMITED TO THE FOLLOWING:**

**Group A Lands** All of Sections 80, 90, 91, 114, 115, 125, 126, and all of Section 148, less the North Half of the North Half of the South Half (N/2 of N/2 of S/2) of Section 148 B all in Block 41, H&TC Ry. Co. Survey in Hemphill County, Texas (hereinafter referred to as the **A Group A Lands@**).

Isaacs, Deceased And Order Distributing Assets Of The Receivership, in which Amarillo National Bank, as Receiver, is the Applicant, and all of the unknown owners or claimants of any title or interest owned by Calvin W. Isaacs, Deceased at the time of his death on February 21, 1955, in the lands owned by Calvin W. Isaacs and His Brothers, John C. Isaacs, II and David Quentin Isaacs, Sr., including but not limited to the Group A Lands, the Group B Lands and Group C Lands, described above, then and there to answer the Application of Amarillo National Bank, Receiver appointed in Cause No. 3295, styled *John C.
