ORDINANCE No. 763

AN ORDINANCE AMENDING THE CITY OF CANADIAN CODE OF ORDINANCES, CHAPTER 13, UTILITIES, ARTICLE 13.05, SOLID WASTE, DIVISION 2 CITY COLLECTION SERVICE, SECTION 13.05.067 RATES, BY INCREASING THE RATES TO BE CHARGED FOR GARBAGE COLLECTION SERVICES FURNISHED BY THE CITY OF CANADIAN, TEXAS; REPEALING ALL ORDINANCES, ORDERS AND RESOLUTIONS IN CONFLICT HERewith; PROVIDING A SAVINGS CLAUSE; AND PROVIDING FOR PUBLICATION AND AN EFFECTIVE DATE.

WHEREAS, the City of Canadian (the "City") operates a utility system for the purpose of providing garbage collection service to its residents and other governmental and private entities; and

WHEREAS, sound business principles require that the City generate revenue sufficient to provide annual operating expenses; and

WHEREAS, the Board of Alderman of the City agree that an increase of garbage collection rates is necessary.

BE IT HEREBY ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CANADIAN, TEXAS:

SECTION 1.

That, Chapter 13, Article 13.05, Solid Waste, Division 2. City Collection Service, Section 13.05.067 Rates, is hereby amended to read as follows:

Section 13.05.067 Rates

- (a) Generally. Monthly rates for garbage collection by the City of Canadian shall be as follows:

TABLE 1

Description	Monthly Base Rate Charge
1. Residential (Single family dwelling)	\$30.05 (for once-a-week pick-up service)
2. Commercial (Any customer not considered residential)	\$45.07 (for each container used by each customer and picked up once each week during a calendar month)
3. Extra, unscheduled pick-up service	\$10.01 Residential \$14.18 Commercial (per container)

- (b) Customers outside city limits: All trash pick-up service provided by the City for customers located outside the City limits, but in Hemphill County, will be charged two hundred percent (200%) of the normal commercial base rate per container (shown in Table 1), plus an additional hauling charge for the specific zone in which the customer is located. Additional charges for each zone shall be incremental as follows:

TABLE 2

Zone A	\$15.52
Zone B	\$33.38
Zone C	\$50.05
Zone D	\$66.74 plus \$4.34 per mile of highway beyond Zone C

A copy of the zoning schedule is attached as "Exhibit A" of this ordinance and a master copy will be available for display at City Hall.

SECTION 2.

That, all provisions of the ordinances, orders, resolutions or parts thereof, heretofore passed and adopted by the City Council of the City of Canadian which are in conflict with the provisions of this Ordinance are hereby repealed, and all other provisions of the ordinances of the City of Canadian not in conflict with the provisions of this Ordinance shall remain in full force and effect.


SECTION 3.

That, if any word, sentence paragraph, subdivision clause, phrase or section of this Ordinance be adjudged unconstitutional or contrary to State or Federal Statutes, and therefore not valid, it shall not impair or affect the validity of this Ordinance as a whole, or any other provision hereof, and all other provisions hereof shall remain in full force and effect.


SECTION 4.

That, this Ordinance shall become effective from and after the 1st day of May, 2024, and the City Secretary of the City of Canadian is hereby directed to post notice at the Hemphill County Courthouse, the Caption, and Effective Date of this Ordinance, as required by Section 2051.047, Texas Government Code.
