The Hemphill County Commissioners offer no objection to the location on the right-of-way of your proposed pipeline and water crossing line as shown by accompanying drawings and notice dated _____ except as noted below.

It is expressly understood that Hemphill County does not purport, hereby to grant any right, claim, title or easement in or upon this highway, and it is further understood that Hemphill County may require the owner to relocate this line, subject to provisions of governing laws, by giving thirty (30) days written notice.

_____ shall hold harmless and indemnify the Commissioners' Court of Hemphill County, Texas, against any and all damages to property or injuries to persons caused by the proposed construction, as well as all damage to vehicles and/or equipment, and by acceptance of this approval agrees to make all changes and alterations to said utility lines as may be required in connection with alteration, paving or relocation of any public road, without cost to Hemphill County.

All work on the highway right-of-way shall be performed in accordance with Precinct Commissioner's instructions. The installation shall cause minimum inconvenience to traffic and adjacent property owners. Special specifications for placing this utility line are as follows:

1. The line laid on county road shall be located as approved by Road Foreman.
2. Water crossing shall be of sufficient width to accommodate all traffic and as approved by Road Foreman.
3. Post adequate warning signs on approaching water crossing from each direction as approved by Road Foreman.
6. Must comply with all State and Federal Laws.
7. **WILL INSURE THAT CONTRACTOR OR SUB-CONTRACTOR WILL NOT OPERATE TRACK TYPE VEHICLES ON OR ACROSS COUNTY ROADS.**
8. **CONTRACTOR IS LIABLE FOR ALL DAMAGES TO COUNTY ROADS AND IF REPAIRS ARE NECESSARY, FOR THE COST OF THOSE REPAIRS AS WELL AS ALL DAMAGES TO VEHICLES AND/OR EQUIPMENT CROSSING WATER CROSSING AS DESCRIBED ABOVE.**
9. **YOU MUST ATTACH A COPY OF THE HEMPHILL COUNTY ROAD MAP WITH THE LOCATION NOTED AS TO WHERE YOU PLAN TO CROSS.**
